Liability Waiver for all Athletes, Coaches, Team Members, Judges, Volunteers

I, _____, knowingly and without duress, do voluntarily submit my entry into the USAWKF National Sanshou Team Trials and Sanshou National Championships. These Team Trials and Championships are hosted by the United States of America Wushu-Kungfu Federation (USAWKF), and organized by United Martial Arts Training Center (UMATC). Hereafter, USAWKF and United Martial Arts Training Center collectively are referred to as the Organizing Committee. I hereby assume all risk of physical and mental injuries, disabilities, and losses, which may result from or in connection with my participation in the tournaments or events. I fully understand that any medical attention or treatment afforded to me by the Organizing Committee will be of the first aid type only. Acting for myself, heirs, personal representatives, and assignees, I do hereby release and forever discharge, and agree to indemnify and hold harmless the Organizing Committee, and their officers, agents, officials, judges, representatives, servants, employees, volunteers, sponsors and all other related members from all claims, actions, suits, and controversies at law or in equity by reason of any matter, cause, or thing whatsoever, that I may sustain as a result of or in connection with my participation in the tournaments or events, use the Organizations equipment and facilities including travel thereto there from, whether due to negligence, omission, default, or other action of any person or entity. I also understand that participation in the tournaments or events, especially but no limited to fighting point or full contact sparring matches, entails a great risk of injury, and I assume full responsibility for all of my actions, intentional or otherwise, during and in connection with my participation in the trials. I agree that my performance, attendance, and participation at the trials may be filmed or otherwise recorded or telecast live. I consent to the use by the Organizing Committee of my name, likeness, voice, poses, pictures, tournaments or events films, ad biographical data concerning fully or in parts, in any form or language, with or without other material, throughout the world, without limitation, for television, radio, video, theatrical motion pictures, internet, or any other medium by devices now known or hereafter devised, and I do hereby waive any compensation in regard thereof as well as any future rights to the aforementioned. I understand that the rules and regulations applicable to the USAWKF and the International Wushu Federation (IWUF) are designed, in part, for the safety and protection of participants. I agree to abide by the rules and regulations established by the IWUF, and the Organizing Committee, of which a copy may be obtained by written request via mail or facsimile.
